## OREGON SOCIETY OF ENROLLED AGENTS BOARD OF DIRECTORS MEETING JANUARY 5, 2018

Eve Davis volunteered to attend the IRS Liaison meeting in Portland.

Maddy Gaoiran will attend the APEX meeting.

<u>Vice President's Report:</u> Maddy Gaoiran gave a written report about reaching out to her clients with regards to the new tax laws that just got signed into law. She also indicated that she wrote to her Congressman in October and November regarding the Tax Reform Bill before it was voted upon. Merkely and Wyden both responded to her letters. Maddy said that she would like to put into the news letter the praise Merkely gave Enrolled Agents. He called Enrolled Agents The Tax Experts. Ira Rosenberg said he would put it in the next newsletter. Maddy thanked Ira for the New Tax Law Resources he has put into the newsletter for our reference.

## **Director(s) Reports:**

- Central Director Cletus Fernandez gave a verbal report. His group held a class in December. He said about 20 people attended. The class grossed approximately \$4000.00 but will confirm that amount with Marie. He also wants to start having regular meetings and possibly some small classes at Daniel Sterns suggestions.
- Central Director Cindy Petersen gave a written report of her resignation due to her moving out of state. She said she would still be an ORSEA member as she will still be in Oregon from Jan-April every year for tax season.
- South Director June Brock gave a verbal report. Her group had a meeting with education and had attendance from some Non-ORSEA members, at the Black Bear Diner in Grants Pass. Daniel Sterns taught the class and approximately 22 people attended. OATC and OSTC also advertised the meeting/education. The board discussed having Daniel Sterns of holding the same type of venue again in possibly Bend.
- Directory At Large Carol Mulder gave a written report about a PAC Formation for ORSEA and a Political Action Committee. Her written report had information about what it takes to develop the committee including the rules and regulations at the Oregon Level. Ira suggested we also look into what the Federal Regulations are for a PAC formation. The board decided that a conversation and suggestions for and Oregon PAC should go the general membership meeting at the State Conference in May. Ira Rosenberg will also put a survey in the News Letter for the general members input of any interest in forming an Oregon PAC. This subject will be tabled until the general membership meeting in May, 2018.

- <u>Annual Conferences</u>- Kirkwood Donavin submitted a written report on the menu(s) for each day of the Conference. The 2018 State ORSEA Conference will be held at the Holiday Inn at Springfield Oregon, (June to confirm the speakers). A motion for the 2020 Conference vote to be held in Hood River at the Best Western passed unanimously.
- Legislation-Daniel Sterns had no report.
- <u>Communications</u>-Ira Rosenberg gave verbal report that the new website is up-to-date, only a few e-mails need revision.
- <u>By-Laws</u>-Caty Giovinco gave a verbal report that she is resigning because she retired. She will be leaving her potion in May. President Daniel Sterns will have to appoint someone to fill her position.
- Government Relations-Michael Davidson gave no report and was not present.
- <u>Nominating Committee</u>-Kirkwood Donavin gave verbal report that there are some positions that will need to be filled on the board. Cletus will be vacating Central Director West, Cindy Petersen is moving and vacating Central East, (there is another member that
